



### **HIGH SCHOOL SENIORS - SCHOLARSHIP ELIGIBILITY**

- Through the Palomar College Council of Classified Employees (CCE), Local AFT #4522 Scholarship Program, scholarships are available to graduating high school seniors who are children or dependents of CCE/AFT #4522 members in good standing, or children of deceased CCE/AFT #4522 members.
  
- Scholarships are available to graduating high school seniors planning to attend community colleges, trade or technical schools, four-year colleges or universities, or art schools. The award grants for the 2019–20 academic year will be a maximum of \$1000 for students attending two-year schools and \$2000 for those attending four-year colleges. The award is for one year only.
  
- Awards are based on the following criteria:
  - o Completion of Scholarship Application
  - o A minimum 2.5 Grade Point Average
  - o Required essay
  - o Proof of member dependency. You must be listed as a dependent on your parents' or guardians' tax return to be eligible for a scholarship.
  
- All complete applications must be postmarked no later than March 8th, 2019. All applicants will receive notice of their status by April 12, 2019.

### **APPLICATION REQUIREMENTS - HIGH SCHOOL SENIORS**

1. **You must use the current year's application form.** The application form must be complete and all requirements must be met to be considered. **Applications without all of the components listed below will not be considered.** Do not send any of the components separately.
2. **Official transcript:** Submit your most recent official transcript, in a sealed envelope, for at least the last three semesters. A minimum 2.5 Grade Point Average is required.
3. **Essay:** In the spirit of Union activism, address a social justice problem and your role in solving it. Your essay must be typed, doubled-spaced, and titled. Essay should not exceed 750 words.
4. **Member verification form:** The Union Verification Form on page 4 must be completed by the applicant's parent or guardian, and submitted with the application.
5. **Proof of Dependency:** Submit Page 1 of your parents 1040 Tax Return- you can black out social security numbers and income if desired.
