



### **Continuing Student Scholarship**

- Through the CCE/AFT #4522 Scholarship Program, scholarships are available to Continuing College students who are members in good standing of CCE/AFT #4522, and spouses, domestic partners, children or dependents of members in good standing of CCE/AFT #4522 and spouse domestic partners, or children of deceased CCE/AFT #4522 members.
- Scholarships are available to continuing college students attending community colleges, trade or technical schools, four-year colleges or universities, or art schools. The award grants for the 2019–20 academic year will be a maximum of \$1000 for students attending two-year schools and \$2000 for those attending four-year colleges. The award is for one year only.
- Awards are based on factors which includes a minimum 2.5 Grade Point Average and a required essay.
- All complete applications must be postmarked no later than April 30, 2019. All applicants will receive notice of their status by May 31, 2019.

## APPLICATION REQUIREMENTS – Continuing College

1. **You must use the current year’s application form.** The application form must be complete and all requirements must be met to be considered. **Applications without all of the components listed below will not be considered.** Do not send any of the components separately.
2. **Official transcript:** Submit your most recent official transcript, in a sealed envelope, for at least one completed semester. A minimum 2.5 Grade Point Average is required.
3. **Essay:** In the spirit of Union activism, address a **social justice problem** and your role in solving it. Your essay must be typed, doubled-spaced, and titled. Essay should not exceed 500 words.
4. **Member verification form:** The Union Verification Form on page 4 must be completed if a dependent is applying by the applicant’s parent or guardian, and submitted with the application.
5. **Proof of Dependency/Marriage or Domestic Partnership:** Submit Page 1 of your parent/guardian 1040 Tax Return or page 1 of your joint filed Married 1040 tax return and or Marriage/Domestic Partner Certificate \*Please strike out SS#s
